ABOUT CHENNAI

Chennai is the capital of the Indian State of Tamil Nadu. Located on the Coromandel Coast of the Bay of Bengal, it is one of the culturally economic and educational Centre in South India. According to the 2011 Indian census, it is the sixth-largest city and fourth-most prominent urban agglomeration in India. The city together with the adjoining regions, constitute the Chennai Metropolitan Area, which is the 36th largest urban area by population in the world. Chennai is among the most visited Indian cities by foreign tourists. It was ranked the 43rd most visited city in the world for the year 2015. The Quality of Living Survey rated Chennai as the safest city in India. Chennai attracts 45 percent of health tourists visiting India and 30 to 40 percent of domestic health tourists. As such, it is termed "India's health capital". As a growing metropolitan city in a developing country, Chennai confronts substantial pollution and other logistical and socio-economic problems. Chennai had the third-largest expatriate population in India at 35,000 in 2009; 82,790 in 2011 and estimated at over 1,00,000 by 2016. Tourism guide publisher - Lonely Planet named Chennai as one of the top ten cities in the world to visit in 2015. Chennai is ranked as a beta-level city in the Global Cities Index and was ranked the best city in India by India Today in the 2014 Annual Indian City survey. In 2015, Chennai was named the "hottest" city (worth visiting and worth living in for long term) by the BBC, citing the mixture of both modern and traditional values. National Geographic ranked Chennai's food as second best in the world; it was the only Indian city to feature in the list. Chennai was also named the ninth-best cosmopolitan city in the world by Lonely Planet. In October 2017, Chennai was added to the UNESCO Creative Cities Network (UCCN) list for its rich musical tradition.

The Chennai Metropolitan Area is one of the largest city economies of India. Chennai is nicknamed "The Detroit of India" with more than one-third of India's automobile industry located in the city. In January 2015, it was ranked third in terms of per capita GDP. Chennai has been selected as one of the 100 Indian cities to be developed as a smart city under Smart Cities Mission.

ABOUT THE UNIVERSITY

The Tamil Nadu Dr. Ambedkar Law University was established by the Government of Tamil Nadu by an Act of State Legislature [Act No.43 of 1997] for the advancement and dissemination of knowledge in learning, teaching and research in the field of law. It holds the pride of being one of the very few Universities to be accredited to NAAC. It strives hard to develop the students and research scholars, a sense of responsibility to serve the society in the field of law by developing skills in advocacy, legal services, legislation and law reforms through better educational instruction and research facilities.

The University is recognized by the University Grants Commission (UGC) under Section. 2 (f) & 12 (B) of the UGC Act, 1956). The University is a member of the Association of Indian Universities (AIU) and Indian Institute of Public Administration, New Delhi. It is functioning as a nodal agency to improve legal education in the State of Tamil Nadu. Within a short tenure, the School of Excellence in Law (SOEL) has emerged as one of the premier Law Schools in the country. The Government of Tamil Nadu offers legal educations through Fifteen of its Law Colleges located at Pudupakkam, Pattaraiperumbudur, Madurai, Thiruchirappalli, Coimbatore, Tirunelveli, Chengalpattu, Vellore, Villuppuram, Dharmapuri, Ramanathapuram, Salem, Namakkal, Theni and Karaikudi. The Central Law College at Salem, Saraswathy Law College at Tindivanam, Mother Teresa Law College at Pudukottai, GTN Law College at Dindigul, KMC College of Law at Tiruppur, Erode College of Law at Erode, S Thangapazham Law College at Tenkasi, Thulasi College of Law for Women Tuticorin, Mugil College of Law at Kanyakumari, SKP Law College at Thiruvannamalai, Sir Issac Newton Law College at Nagapattinam, Anandam Law College at Thanjavur are the Eleven Private Law Colleges affiliated to the Tamil Nadu Dr. Ambedkar Law University.

The Tamil Nadu Dr. Ambedkar Law University remains to be the first and unique affiliating type of Law University established in South Asia. There are more than Twelve Thousand students pursuing their law degrees through its Affiliated Law Colleges, in addition to School of Excellence in Law. The Tamil Nadu Dr. Ambedkar Law University as a nodal agency has been admitting the students for all the Government Law Colleges and the Private Law Colleges. It has got the appreciation from the High Court of Chennai for its transparent admission process in the previous years. Many students from School of Excellence in Law have been appointed as judicial officers. Of around 1000 institutions offering legal education in India, The Tamil Nadu Dr. Ambedkar Law University has been ranked prominent.

LOCATION AND INFRASTRUCTURE

Chennai, formerly known as Madras is the Capital City of the State of Tamil Nadu. Chennai is the fourth largest Metropolitan city in India. It is a large commercial and industrial center, and is known for its cultural heritage and temple architecture.

The Tamil Nadu Dr. Ambedkar Law University has two campuses. One is situated at No.5, Poompozhi, Dr.D.G.S. Dinakaran Salai, Raja Annamalaipuram, Chennai- 600 028 between the Tamil Nadu Dr. J. Jayalalithaa Music and Fine Arts University and Iyyappan Temple [MRC Nagar] on the banks of Adyar River and has been functioning from its establishment in the year 1997. The new campus is at M.G.R Salai, near Taramani MRTS Railway Station, Perungudi, Chennai- 600 113, established in around 15 acres of land with the financial assistance of Rs.59.27 Crores funded by the Government of Tamil Nadu. The new campus was inaugurated by the then Hon'ble Chief Minister of Tamil Nadu on 14.02.2016. While the administrative affairs of the University has been retained in the Poompozhi campus, the academic activities offered at the School of Excellence in Law has its functioning at the Taramani campus since 22.02.2016. Both campuses of the University are well connected by Road, Rail and Air. The High Court Complex is within 15 kilometers from the University campus. This facilitates easy and effective interaction between the Bench, Bar and the University. The Tamil Nadu State Judicial Academy and Anna Institute of Management are located just 0.5 Km from the Poompozhi campus. The jurisdiction of the University covers the entire State of Tamil Nadu. All the Law Colleges are affiliated to this University. As a full-fledged first affiliating Law University in the Country, the University has plans to expand its academic tenets to cover other parts of the Country in general and the State of Tamil Nadu. The Government of Tamil Nadu has allotted another piece of land at Tambaram village for its future expansion activities.

Waiving of Fee for SC/ST, Differently Abled and First Graduates from a Family

Differently Abled Candidates on submission of appropriate certificates issued by the concerned authorities are exempted from paying Tuition Fee and Special Fee. Candidates belonging to SC/ST communities, on submission of community certificates issued by the appropriate authority are exempted from paying Tuition Fee. They have to pay only the Special Fee at the time of Admission. In respect of First Graduates from a family, the First Graduate Candidates on submission of appropriate certificates issued by the concerned authorities are exempted from paying Tuition Fee. They have to pay only the Special Fee at the time of Admission.

COMMON FACILITIES

The Tamil Dr.Ambedkar Law University has adequate facilities for teaching and learning. The academic activities are now offered at the School of Excellence at the Perungudi Campus. It has separate Blocks for U.G. and P.G. Programmes with spacious, well equipped and IT enabled Class Rooms and

Seminar Halls. The whole campus is Wi-Fi enabled. The campus encompasses an Administrative Block, Amenities Block, a well-equipped, spacious Library and adequate Sports Facilities with separate Hostel for Girls. The amenities for Boys Hostel have been provided at the Poompozhil Campus.

LIBRARY

The Tamil Nadu Dr. Ambedkar Law University was established by the Government of Tamil Nadu by an Act of State Legislature. The present magnificent Ground + Three Floors Library Building started functioning from March 2016 with a carpet area of 4,088.64 sq.m. The Library building is fully Air conditioned and used to accommodate sections such as Stock, Reference, Circulation, Periodical, Technical Section, Digital Library Section, Thesis & Dissertation, Reprography and a separate section for Visually Challenged/Differently Abled users. The University Library established a Differently abled Section exclusively for the welfare of differently abled users in October 2016. The University Library has a total collection of 40,061 books which includes e - books and is also subscribing more than 55,367 journals which includes online as well as print journals both National and International. The library has a rich collection of books in various sub-disciplines of law. The Library has More than 2000 M.L./L.L.M. dissertations of the Tamil Nadu Dr. Ambedkar Law University and its affiliated Law Colleges. It has an enviable collection of reference books and journals viz. AIR Manual, American Jurisprudence, Corpus Juris Secundum, Halsbury's Laws of England, Halsbury's Laws of India, International Law Reports, US Supreme Court Reports, Words and Phrases, Encyclopedia Britannica, Encyclopedia of Social Sciences, Encyclopedia of Intellectual Property Rights, International Encyclopedia of Social Sciences and etc., The back volumes of 69 journals are also available.

Scheme of Classification

The Library has adopted Dewey's Decimal Classification (DDC) for classifying the books and Anglo-American Catalogue Rules (AACR - II) has been used for cataloguing the books. The catalogue of the library is computerized and it is available in the Local Area Network (LAN) of the University.

Library Automation

The University Library is automated by Library Management System namely KOHA which has been linked with Radio Frequency Identification Detention (RFID) Technology. The books can be issued, renewed and returned by this technology through Self Service Kiosk for Issue & Renewal, Intelligent Shelf and Book Drop Box for Return. The Online Public Access Catalogue (OPAC) is available through Internet and Intranet.

Self Service Kiosk

To save the time of the users, the University Library has Two Self Service Kiosk which enables the members' viz., Faculties, Research Scholars and Students to take the books and renew the books by themselves. The users will get the receipt with due date for the next transaction.

Book Drop Box

University Library has One Book Drop Box. This facility has been utilized by the Faculties, Research Scholars and Students to return their books and get their acknowledgement receipt even the library is closed.

Intelligent Shelf for Return of Books

University Library has One Intelligent Shelf for Return of Books which enables the members' viz., Faculties, Research Scholars and Students by themselves to return the books and the users get their receipt for returned books.

Digital Library of Theses and Dissertations

The University Library has made MOU with UGC SHODGANGA. The thesis submitted by research scholars of the Tamil Nadu Dr. Ambedkar Law University has been digitalized and published in the INFLIBNET Portal.

Library Consortia

The University Library is a core member of Digital Library Consortium of UGC INFONET. Through this library provides access to legal database throughout the campus with Wi-fi connectivity. The University Library is one of the foundation members of the LAWNET library consortia which share the information.

Network

The University has 1 GB ILL (Internet Least Line) Internet connectivity through NMEICT project by MHRD. The university is well connected by Local Area Network. The University Library provides Wi-Fi facility to entire campus and CCTV surveillance in the campus.

Digital Library

The Digital Library consists of 160 systems and a server which have been connected with Local Area Network (LAN). The digital library provides access to the global information to the users in the desktop.

Visually Challenged/Differently Abled Users Section

The Differently Abled users need special arrangements in the environment for their mobility and independent functioning. University Library has created special facilities such as ramps, rails and special toilets, and makes other necessary changes to suit the special needs of differently-abled and visually challenged users. In order to cater the needs, library provides aids for the disabilities viz., JAWS Talking software for the Blind, MaGic screen Magnification Software without Speech, MAGic Large Print Keyboard, Topaz 20" Inch desktop video Magnifier, Zoom Ex Instant Reader, SARA CF instant Text Reading Machine, Focus 40 Blue Refreshable Braille display and Ruby Handheld Video magnifier.

Talking Book Library has been Angle Pro Talking Daisy Player / E-Book Reader for the blind and also Braille Book Library has been Index Basic D-V4 Translation Software, Duxbury Braille Translation Software, Tractor Feed Braille Paper (1000 Sheets in 1 Box) and Acoustic Cabinet for sound proofing for the benefit of Visually Challenged / Differently Abled persons.

Book Bank Facility

University Library is having Book Bank facility and the total collections of Book Bank Books are 4778. These books have been provided for the benefit of the SC/ST students under SC/ST Book Bank Scheme.

Book Exhibition

University Library is conducting Book Exhibition every year with maximum discount on all books which will be highly useful to the students, staff and research scholars to know the new arrival of books and to purchase for them and recommend for the library.

THE PLACEMENT CELL

The Placement Cell of the School of Excellence in Law, The Tamil Nadu Dr. Ambedkar Law University, plays a pivotal role in facilitating career opportunities and professional development for students. During the academic year 2025–2026, the Cell focused on structured placement support, skill development, and strengthening industry connections, operating on principles of transparency, equal opportunity, and merit-based access. It successfully contacted over 47 firms and organization and circulated more than 23 career opportunities, ensuring consistent engagement between students and the legal industry.

A key aspect of the Placement Cell's work was the organization of career development initiatives aimed at exposing students to diverse legal career paths. Notable programmes included sessions on civil services preparation, litigation practice, and corporate law careers, along with an innovative podcast titled "Law Unboxed," which connected students with legal professionals and alumni. These initiatives provided practical insights, mentorship, and clarity on career progression, significantly enhancing student preparedness.

In terms of placement outcomes, the Cell successfully placed several students in reputed organization such as TATA AIG, SBI General Insurance, SAPR Law, and Clean-tech Industry Resources, with the highest number of placements secured at SBI General Insurance. Additionally, the Cell expanded its internship database and facilitated opportunities across multiple domains, including litigation, corporate law, intellectual property, and policy research.

The Placement Cell also undertook extensive outreach efforts, engaging with law firms, advocacy chambers, and corporate legal departments to broaden placement avenues. While corporate outreach did not yield immediate results, it established a foundation for future collaborations. Overall, the activities of the Placement Cell during the year reflect a strong commitment to student career advancement, and future plans include enhancing recruiter engagement, increasing corporate placements, and conducting targeted skill-based training programmes to further improve placement outcomes.

MOOT COURT

The Moot Court Association (MCA) of the School of Excellence in Law continued to demonstrate remarkable academic excellence and advocacy skills during the academic year 2025–2026, with students achieving significant success in numerous national and international moot court competitions. The consistent participation and outstanding performance of students reflect the institution's commitment to fostering legal research, drafting, and oral advocacy. Across various competitions, students not only secured top positions such as winners and runners-up but also earned individual recognitions along with cash prizes, further highlighting their competence in the field of law.

One of the most notable achievements of the year was the victory at the University of Staffordshire & REVA International Moot Court Competition, where the team comprising Fatma Al Zahra, Ashwad Dhinakaran, and Nivethitha Mahadevan emerged as winners. Competing against international teams, they demonstrated exceptional legal acumen and advocacy skills. In recognition of their outstanding performance,

the team was awarded a cash prize of USD 1,200 (approximately INR 1,00,000), marking a significant milestone for the institution on the global stage. Similarly, the team consisting of Ashwad Dhinakaran, Maryum Ameen, and Tamil Iniyan E secured the winner's position at the 5th Justice Santhosh Hegde National Moot Court Competition 2026. Their performance in a highly competitive environment, involving premier law institutions, showcased their analytical abilities and courtroom excellence.

Another remarkable achievement was recorded at the NLST Moot Court Competition 2026, where the team comprising Z Mohamed Zayd, N E Tamil Iniyan, and Sai Venkat V emerged victorious after progressing through multiple rigorous rounds. Their victory was complemented by a cash prize, reinforcing their excellence in advocacy and legal reasoning. Additionally, the team of Afiya Parveen A, Sai Shruthi A, and Arun A secured the winner's title at the Kristu Jayanti Moot Court Competition 2026. Their consistent performance from preliminary rounds to finals earned them not only the championship trophy but also a cash prize, emphasizing their dedication and skill.

The institution also witnessed several commendable runner-up finishes across prestigious competitions. At the 2nd All India Moot Court Competition 2025 organized by Government Law College, Puducherry, the team comprising Vaishali G, Raja Kaleeshwari K, and Sameeha Mariam secured the runners-up position after competing against 69 teams nationwide. Similarly, the team of Monica B, Anushree Tamilkumar, and Tharun Pranav AG achieved the runners-up position at the Surana & Surana Judex 3.0 Human Rights Moot Court Competition. Their performance was further distinguished by winning the Best Memorial Award, showcasing their excellence in legal drafting alongside oral advocacy.

An academic year is divided into two semesters consisting of 90 working days in each semester. The Integrated Degree will be awarded only on successful completion of the course. No split degree will be issued during the pursuance or on exit in the midst of the 5 Year Integrated Course.

Intake

The number of students to be admitted in each of the Integrated Degree Course shall be 156* (inclusive of NRI). All efforts will be taken to pay individual attention to every student.

**As per G.O.Ms.No.418 Law (LS) Department dated 30.07.2012, on the basis of merit list, 4% of the total seats have been allotted to the Higher Secondary Courses (+2) Vocational Stream Candidates.*

Non-Resident Indians (NRI) Quota

Of the total number of seats 15% has been earmarked for NRI candidates. Unfilled NRI seats will be converted to general and filled as per merit.

Eligible Qualification

- A Candidate should have passed **Higher Secondary Examination (10, +2) OR completed 3 Year Diploma /Polytechnic** in the recognized Educational Institution (*Approved as per the Order of the Hon'ble High Court of Madras in W.P.No.18822 of 2022 dated 23.12.2022*) should have secured not less than **70%** of the total marks in the aggregate of all the Subjects.
- The applicants who have obtained 10, +2 directly without having any basic qualification are not eligible for admission to the Law Courses.
- The Candidates belonging to Scheduled Caste / Scheduled Tribe communities should have secured not less than **60%** of the total marks in the aggregate of all the Subjects.
- NRI Candidates, claiming under the Non-Resident Indians (NRI) category, should have secured not less than **70%** in the qualifying examination.
- Candidates aspiring to apply for **B.Com.LL.B.[Hons.]** must have studied **Commerce or Equivalent subject related to Commerce alone** as a subject in the Higher Secondary Examination.
- Candidates aspiring to apply for **B.C.A.LL.B.[Hons.]** must have studied **Computer Science or Equivalent subject related to Computer Science alone** as a subject or equivalent subject in the Higher Secondary Examination.
- **Candidates having ITI qualification instead of Higher Secondary Course (+2) are ineligible.**

For 5 Year B.A.LL.B.[Hons.], B.Com.LL.B.[Hons.], B.B.A.LL.B.[Hons.] and B.C.A.LL.B.[Hons.] Degree Courses:

1. **FOR CANDIDATES COMPLETED +2:** The percentage of marks obtained by the candidates in the Plus Two examinations excluding Languages will be taken into account.
2. **FOR CANDIDATES HAVING DIPLOMA OR POLYTECHNIC:** The percentage of Marks obtained in Subjects excluding languages, Practical Papers and Skills papers such as life skills, Communications skills, etc. will be taken into account as **Stipulated in G.O. (MS) No.302 Law, (LS) Department, and Dated 30-05-2023. The respective G.O. will be uploaded in the University Official Website.**

NOTE: 1. The Rank list and the Cut-Off Marks shall be calculated and published according to the claim made by the Applicants in their respective Applications. Modifications in the Application will not be entertained.

2. *The marks obtained by them in the improvement examinations shall not be taken into account.*

NORMALISATION PROCESS

By normalization process highest marks obtained by the students of State Board in that subject and the relative marks obtained by other students in the subject shall be determined accordingly.

Illustration: If the highest marks secured by the student of State Board in Physics is 100 and the highest mark secured by a student of any other Board in the same subject is 90, both the highest marks will be considered to be equal to 100. If a student of the other Board secures 60 marks in Physics when the first mark in Physics in the same Board is 90, the 60 marks will be considered to be equal to 66.66 marks as arrived at below:

3 Year LL.B. [Hons.] Degree Course

Course Structure

LL.B.[Hons.] Degree Course is of 3 years duration. Each Academic Year is divided into 2 Semesters and each Semester consists of 90 working days. On successful completion of the course, LL.B.[Hons.] Degree will be awarded.

Intake

The number of students to be admitted in the 3-year LL.B. [Hons.] Degree Course shall be 156 (inclusive of NRI).

Non-Resident Indians (NRI) Quota

Of the total number of seats, 15% has been earmarked for NRI candidates. Unfilled NRI seats will be converted as General and allotment will be made on merit.

Eligible Qualification

- A candidate should have passed any Under Graduate Degree and should have secured not less than 60% of the total marks in the aggregate.
- The candidates belonging to Scheduled Caste / Scheduled Tribe communities should have secured not less than 55% of the total marks in the aggregate of all subjects.
- In case of students who make a claim under the Non-Resident Indians (NRI) category, they should have secured not less than 60% in the qualifying examination.

NOTE:

- a) The Eligibility Criteria for Admission is as per the Bar Council of India Regulations-2008 and State Government Norms. The eligibility norms as prescribed by the University and approved by the Syndicate are as follows:
 - **The candidates should have Educational Qualification in the 10+2+3 or 10+3+3 Format only.**
 - **The candidates who have completed 10+2 or Graduation/Post Graduation in case of Integrated Course through Open University System directly without having any basic School Education qualification are not eligible to apply.**
- b) **Employed candidates are not eligible to apply.**
- c) **ITI are not eligible as it is not equivalent to Higher Secondary Course that is 12th Standard.**
- d) **No Age limit for admission.**
- e) The determination of the Community for the **Transgender or Eunuch (Thirunangai or Aravani)** shall be followed as per G.O. Ms. No.90 by the Department of Social Welfare and Nutritious Meal Programme [SW8(2)] dated 22.12.2017, ...*"who belongs to the SC/ST/SC(A) and possess Community Certificate as such they may be considered as per their respective Community. The Third Gender candidate who belong to the Community other than SC/ST/SC(A) and possess Community Certificate may be considered as per their own Community or as Most Backward Class which is advantageous to them as per their option and once the individual exercises option for Community selection in should be crystallised and this option should not be changed in future"*.

- f) Candidates should have obtained the Degree/Provisional Certificate in the qualifying examination on the date of their Counselling. Otherwise, their candidature will not be considered.
- g) Candidates shall furnish the photo copy of the Consolidated Mark Statement of their qualifying degree course obtained from the University or from the institution where they studied, along with the application.

Admission to the three-year LL.B.[Hons.] Degree Course to be made only on the basis of marks obtained in the qualifying examination and following the rules of reservation of the State.

- (i) "The percentage of marks obtained by the candidate in aggregate of all the subjects in the qualifying degree examination, excluding languages, may be taken into account. In case, where the language alone is the subject to qualifying examination, the percentage of marks obtained by the candidate in the said examination may be taken into account" (G.O. Ms. No.83 Law (LS) Department dt.19.04.2007).

PROHIBITION OF RAGGING:

As per the directions of Hon'ble Supreme Court of India, UGC and Tamil Nadu Prohibition of Ragging Act, 1997, Ragging is an offence, and is banned in the Institutions. Anyone indulging in Ragging is liable to be punished with rigorous imprisonment up to 3 years, and or fine up to Rs.25,000/-, besides expulsion from the Institution. As per UGC norms, the University has constituted the Anti Ragging Committee. Students affected due to ragging can approach the Committee members and the committee will ensure strict compliance of Anti -Ragging measures in the Law University.

ADMISSION UNDER NRI QUOTA
(Applicable only for 5 Years & 3 Years Honours Law Courses)

Admission to the NRI quota will be made in the following order and as per merit on the basis of marks secured by the candidate in the qualifying examination.

Category I-NRI Parent : The Parent (either Father or Mother or both must be an NRI)
(In case of a candidate seeking admission for the 3 Year LL.B. Degree Course when he/she himself/herself is an NRI)

Category II - NRI Guardian : If the candidate has no Parent where he/she has been taken as a ward by a nearby relative or someone and such NRI Guardian has been legally declared as the Guardian of the Candidate by the Court as per provision of Guardians and Wards Act, 1890.

- In each and every category, candidates will be selected based purely on inters merit. As per the orders passed by the Supreme Court and Resolution passed by the TNDALU Syndicate, "No NRI shall be permitted to sponsor any Candidate".

LL.M. DEGREE COURSE

The Tamil Nadu Dr. Ambedkar Law University, through its Post Graduate Department imparts courses leading to award of LL.M. Degree under the Choice Based Credit System (CBCS). The Post Graduate Department offers LL.M. Degree in Thirteen specialized branches of Law. Periodically various Seminars/Workshops/Symposiums are being conducted to give exposure for students pursuing the course. Placement avenues are created to benefit the Final Year Students of the LL.M. Degree Courses.

LL.M. Degrees, under the CBCS pattern, in the following Thirteen Branches:

- Branch I** : Business Law
- Branch II** : Constitutional Law and Legal Order
- Branch III** : Intellectual Property Law
- Branch IV** : International Law and Organization
- Branch V** : Environmental Law and Legal Order
- Branch VI** : Criminal Law and Criminal Justice Administration
- Branch VII** : Human Rights Law
- Branch VIII** : Labour Law and Administrative Law
- Branch IX** : Taxation Law
- Branch X** : Cyber Space – Law and Justice
- Branch XI** : Maritime Law
- Branch XII** : Property Law
- Branch XIII** : Crime and Forensic Law

Intake and Reservation

The number of students to be admitted in each branch of the LL.M. Degree Programme is limited to 20. For each of the branches, the reservation will be based as per the Reservation Policy adopted by the Government of Tamil Nadu.

Eligibility

The general eligibility condition for admission to Master's Degree Programme is as per the UGC norms.

Candidates who have successfully completed a Three Year / Five Year Under-Graduate Degree Course in Law conducted by the University or equivalent there to shall be eligible for admission to a Master's Degree Programme in any of the LL.M. Courses. Candidate should have obtained a minimum of **45%** of marks under New Regulations [**40%** under Old Regulations]. The candidates should have completed the course through the formal education in the 10+2+3 or 10+3+3 format. Admission will be conformed only on production of all the original certificates.

Course Structure & Duration

The Tamil Nadu Dr. Ambedkar Law University offers LL.M. Degree Courses under the CBCS pattern. The course is of Two Years duration. Each academic year is divided into 2 Semesters (odd and even). Each semester consists of 90 working days which extends over a period of 15 weeks. The semester pattern is designed with continuous Assessment System.
